For this purpose seniority is determined by the order in which the names stand in the Register of Members in respect of the joint holding.
- In the case of a corporation this form of proxy must be under its Common Seal or under the hand of an officer or attorney duly authorised.
- To be valid this form of proxy together with any power of attorney or other authority (if any) under which it is signed or a certified copy of such power or authority must be deposited at the Company's registered office at 72-76/F, Two International Finance Centre, 8 Finance Street, Central, Hong Kong not later than 48 hours before the time of the meeting or any adjournment thereof.
- Any alterations made in this form should be initialled by person(s) who sign(s) the form.
